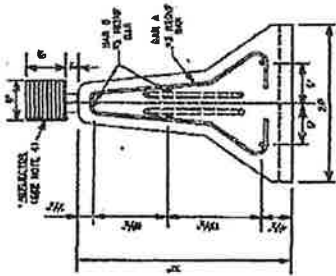

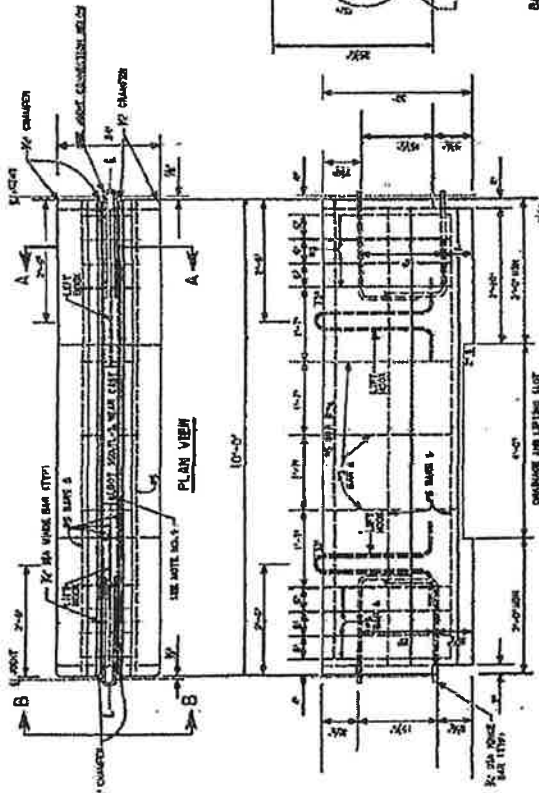

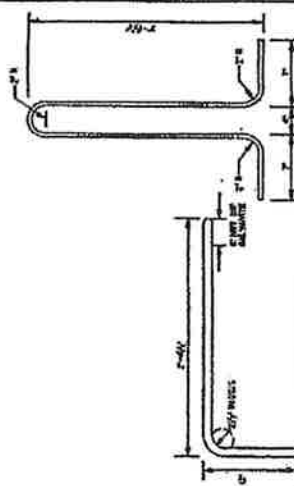

ELEVATION VIEW

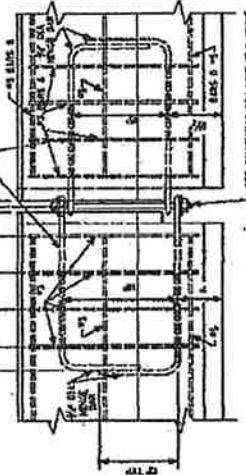

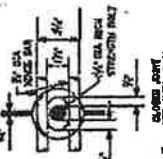

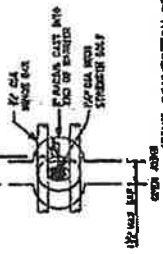
