All checks shall be returned promptly, except the check of the successful bidder, which shall be returned after fulfilling the bid.

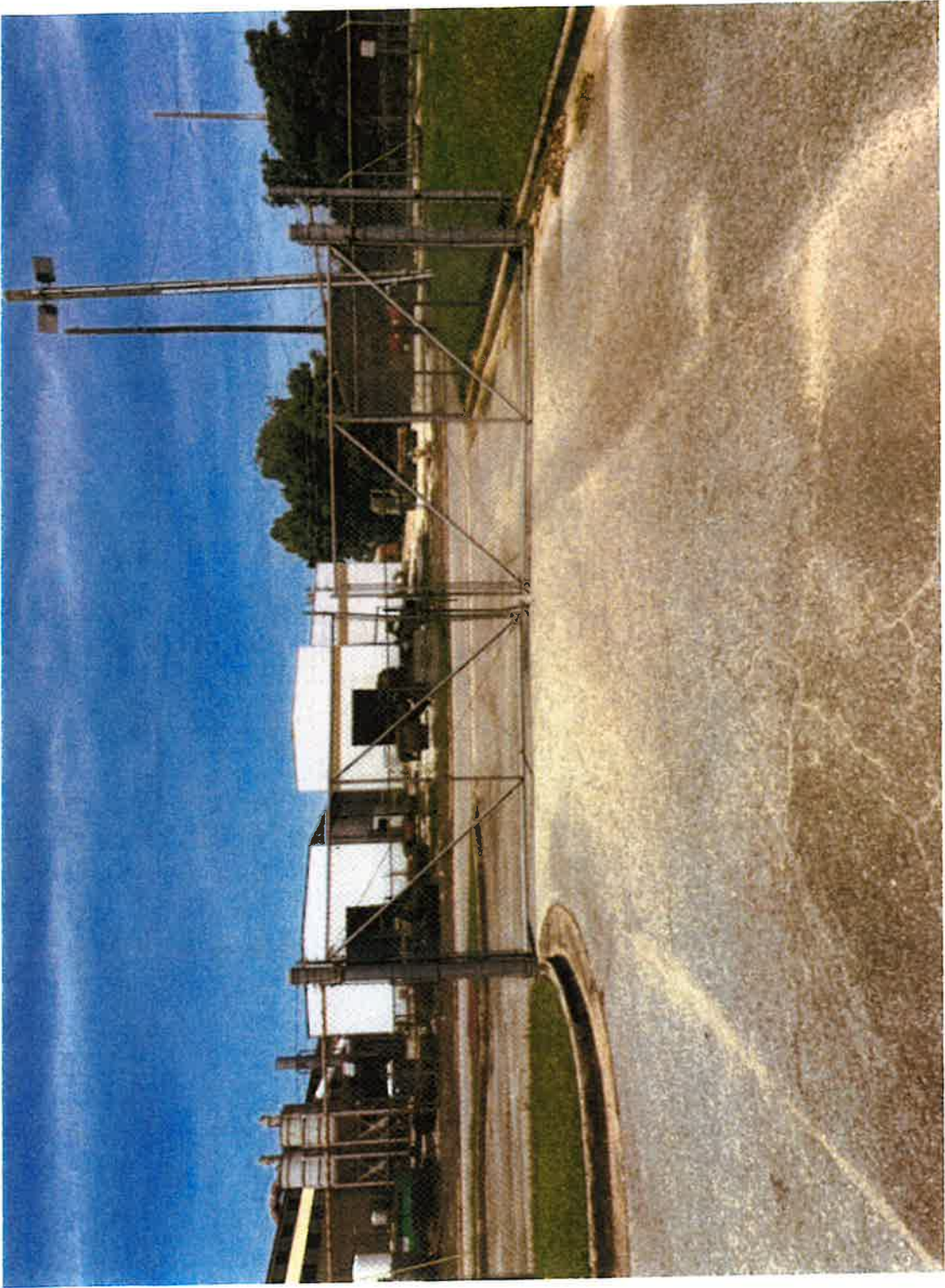

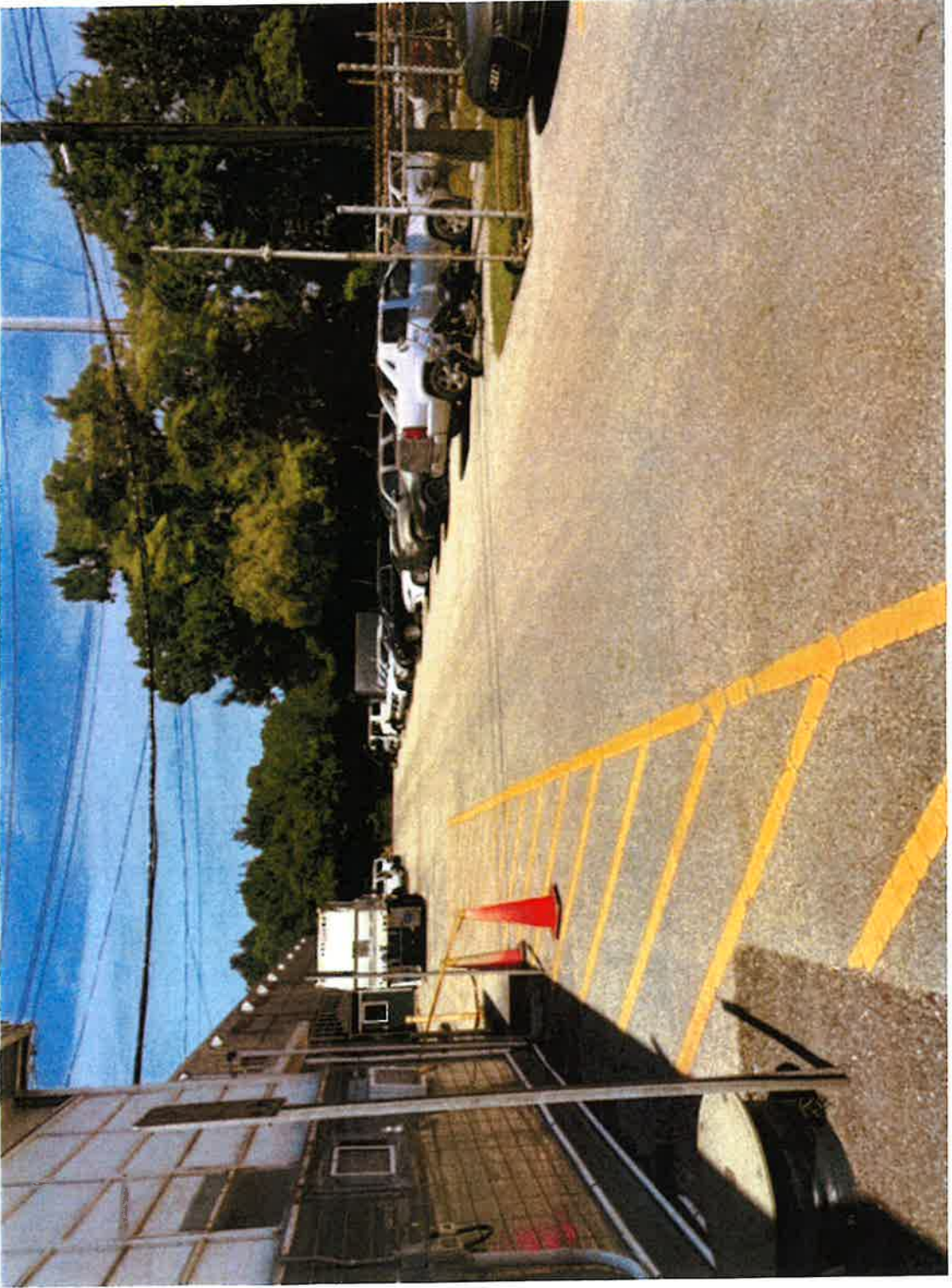

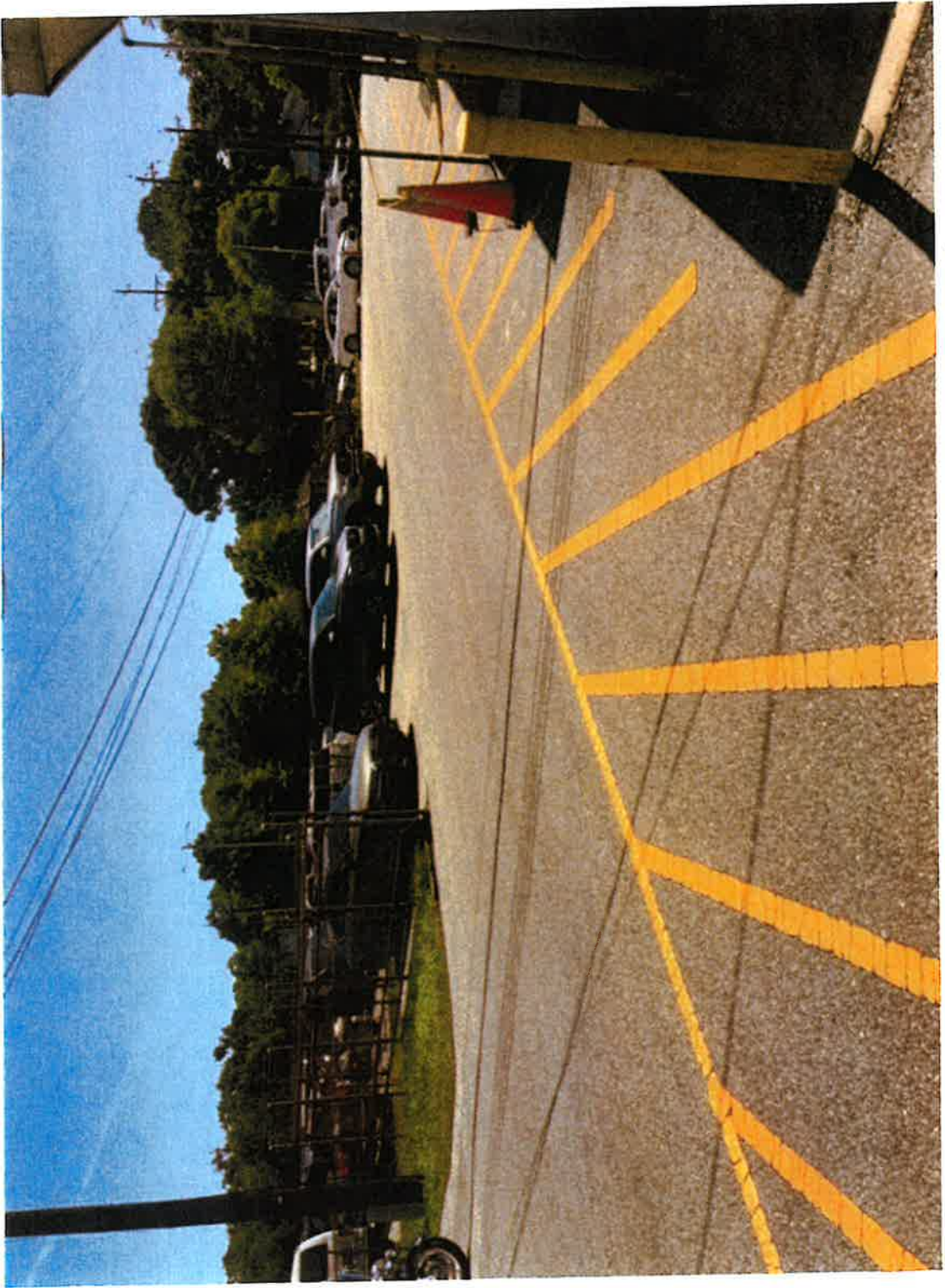
